Superintendent's Note

As we move into the fourth quarter of the school year, our hopes are high that we are through the worst of the pandemic. Smiling faces abound as our absence rate is low, our substitute fill rate is high, and we are revving our engines for a smooth ride into

summer. Another part of our efforts this last quarter is to ensure that our success continues for many years to come.

As we have shared, the elected board of Mt. Vernon Schools has chosen to put a referendum on the May 3 ballot in order to ensure we maintain revenues in our Operations Fund after the loss of the Increment dollars and increasing tax cap losses. Additionally, our operating referendum will allow us to increase pay for our teachers and classified staff who take care of our students on a daily basis. Bringing those wonderful Mt. Vernon employees closer to market wages is a big part of ensuring a bright future for our school district.

I've been sharing our story with parents and community members through weekly Virtual Traveling Talks and one of the common questions include "Why did we land on a \$0.17 rate?". That rate is quite low in comparison to other school referenda in central Indiana, and that is because we are only asking for what we need. Additionally, a referendum spreads the cost to all taxpayers, including those

Referendum Facts – SAVINGS MADE, THE ASK & USE OF FUNDS



As part of the upcoming May 3 Primary ballot, registered voters who live within the Mt. Vernon Community School Corporation will have the opportunity to **vote on the operating referendum question placed on the ballot by the MVCSC Board of Trustees after considerable public input.**

Here are key referendum facts:

- Voters will decide on a proposed operating referendum of **17 cents per \$100 of net assessed value on homes or businesses.**
- If approved, the referendum would generate **\$3,201,692 annually to retain and attract outstanding teachers and staff, to support MVCSC general operations, help pay for utilities, transportation and support staff.**

warehouses in TIFs who have captured taxes for redevelopment. Since 2012, \$288,000,000 of non-residential assessed valuation has been captured in a TIF. Should the referendum pass, those businesses in a TIF will be paying a school tax, likely for the first time.

An additional question we receive relates to transfer students. Transfer students, while consistently declining, have no negative impact on our Operations Fund. Since the state implemented a plan to allow schools to send and receive students from other enrollment areas, the money received for tuition follows the child. Mt. Vernon ranks third in net transfer students behind both Southern Hancock and Eastern Hancock. For Mt. Vernon, about 11% of students living in our district transfer out of our district while 15% transfer in and that is going down consistently each year.

Finally, we answer the question related to revenue and expenses in our Operations Fund. Our school district ranks in the middle of the two most comparable districts (Southern Hancock and Greenfield-Central) regarding both revenue and expenses. We are good stewards of our resources and our team works hard to save money every chance we get.



- Several factors led to the Board's decision to place a referendum on the ballot:
 - **Increment Loss: Our Increment dollars (\$3.3 million annually for 10 years) that support approximately one-third of our Operations Fund revenue will end in December 2022.** This will create a deficit that will impact the district's ability to support our 4,500 students.
 - **Fire Territory Financial Loss:** While we support having adequate fire response teams, **the fire territory development reduced our Operations Fund revenue by just over \$1 million, annually.**
 - **Tax Cap Loss:** MVCSC experiences a **high tax cap loss, spanning from \$3.5 million in 2021 and an expected \$3.8 million in 2022.**
- **Savings made by MVCSC.** Because the school corporation has been aware of the factors listed above and their effect on revenue, **MVCSC has reduced expenditures and initiated many savings totaling more than \$2 million each year.** These are real savings to you and other taxpayers in our school community.
- **The Ask:** While the \$0.17 ask is an investment of \$14.02 per month to the average household in our district valued at \$201,000, **the referendum will also tax businesses located in TIF districts that are currently not paying taxes.**



Funds Will Be Used for:

- The referendum funds will help **retain teachers and classified staff.**
- This will better enable us to **maintain our low class sizes and continue our "A" rating** from the Indiana Department of Education for our schools.
- These referendum funds would additionally **provide at least one School Resource Officer in all schools and two at the high school – to ensure the safety of our 4,500 students.**
- The referendum funds would replace the increment dollars and fire territory revenue loss, making our Operations Fund solvent. We have **made enough savings to not need to recapture the full Operations Fund revenue loss of over \$9 million.**

Our Mt. Vernon Schools **join over a hundred other Indiana school districts in seeking the support of residents via the public referendum process.**

Dr. Parker invites the community to join him for an open-forum discussion in this spring's remaining **Traveling Talks** meetings. The Traveling Talks, which Dr. Parker has been conducting for the past several months, are a mutually beneficial opportunity for the community to connect with the school district, and for school leadership to get to know more about you and other residents of the community. Dr. Parker will share facts about the May 3 referendum and will provide an overall update on the status of our school district. Cost-Cutting Corner

Mt. Vernon Community School Corporation is always seeking opportunities to stretch tax dollars and identify both short- and long-term savings. Here are a few examples from the past year:



- The **installation of LED lighting district-wide**. An investment of \$841,335 will yield total maintenance and utility expense savings of \$1 million over 11 years.
- Middle school **renovations to art, music and cafe** were budgeted at a minimum of \$3.7 million in construction costs. The final cost remained at \$3.7 million, but eventually included all alternate bids (**upgrades**) at **no additional cost**.
- District-wide HVAC and mechanical/electrical/plumbing upgrades. For an investment of \$8.4 million, the total maintenance and **utility expense savings over six years is \$10.2 million**.
- **The Stewardship Project costs (mainly updating roofs & HVAC systems) came in under original budget projections, which allowed an investment of \$500,000 in technology infrastructure upgrades** to the middle school without increasing total project costs.
- The anticipated increase in property values for the budget year 2022 will allow the district to pay back the 2022 bus financing and a \$2.7 million dollar General Obligation Bond in one year, **(for continued Stewardship Project improvements), thus saving an additional year of financing and interest costs - all without an increase to the debt service tax rate**.
- The cost for **installing ionization air purifiers for all classrooms throughout the district** came in under budget with a saving of \$20,000 and is financed through the federal ESSER III grant - designed to assist schools with pandemic-related expenses.
- The East Central Indiana Natural Gas Consortium (ECINGC), of which Mt. Vernon is a member, last fall agreed unanimously to purchase natural gas at current market rates, stockpiling supplies for winter 2021-2022. **With gas rates increasing rapidly, this early purchasing resulted in substantial savings**.
- The district is also **evaluating its purchasing and procurement processes in order to gain savings** in the future.

Walk on Water is a Floating Showcase of Student Learning

Mt. Vernon Middle School (MVMS) eighth graders recently participated in the annual Walk on Water science experiment. Multiple teams competed in the project, which challenged students to use their critical thinking skills. Each team built a float that would allow one member of their team to "walk" across the length of the pool. The floats were not tested until the day of the challenge. If the float sank before it crossed the pool, the team was out of the competition.

The project is designed to test students' knowledge of problem solving, the scientific method, planning a long-term project, teamwork and writing a formal lab report. Students are encouraged to think outside of the box. Some of the scientific concepts the students have to consider are: propulsion, density, energy, energy transfer, Newton's Laws, and stability.

Mrs. Stacy Griner, Eighth Grade Science Teacher and also "Walk on Water" creator stated, "The project gives an exciting way for the students to engage in their learning. They have to work as a team, use critical thinking skills and scientific knowledge to choose their device and physically build it. The kids love it and really get into the project and the secrecy of their construction."




Many teams were in the spirit of the event and dressed up in their float's theme. Superheroes, tutu's, butterflies and lifeguards were all popular themes this year.
